PRIZE GAME RULES

Article 1.

The limited liability company AQUA PARK d.o.o., from Poreč,Partizanska 4/1, OIB 32451961067 (hereinafter: the Organizer) organizes a contest "**Citroen summer edition 4 you**" to the following rules.

Article 2.

The prize game is being organized in order to promote the organizer, and to enhance and improve the activities of the Organizer in the water park Istralandia, Ronki 1 ,52474 Brtonigla .

Article 3.

The awards provided for this prize game are exhibited in the atrium space of the water park Istralandia, Ronki 1 , Nova vas, 52474 Brtonigla in the period marked in the following Article.

The prize game begins on the publication day of the rules at www.istralandia.com or from the 3 rd of June and lasts up to 17th of September 2017.

During this period, the prize game has a defined duration time as follows:

1.Prize game water park Istralandia » Istralandia summer edition 4 you« from the 3rd of June 2017. at 10:00 AM to the 17th of September 2017 at 07:00 PM.

Article 4.

The draw will take place at the water park Istralandia according to the defined dates from Article 3. and starting at 04:00 PM on the 17th of September 2017 in the presence of 3 commission members and the presence of a public notary. The above - mentioned commission members will take over coupons and transfer them to the main drum from which they will be drawn.

Article 5.

The prizes for allocation:

1. Prize: Car Citroen C3 FEEL PURE TECH 82 BVM,

2. Prize: A 7 day stay on bed and breakfast basis for two persons in Aminess Hotel
Maestral Novigrad 11.844,00 kn

The total prize value is **107.844,00 kn**. (tax included)

Five percent (5 %) from the value of the overall prize fund, ie **5.392,20 kn**, is Paid to The Croatian Red Cross account : IBAN HR 73 2360000 – 1101396032.

Article 6.

All visitors of the Aquapark Istralandia with a paid ticket which has a copy of the prize coupon, with a valid date can participate in this prize game. The visitor must complete all required information on the coupon to be valid: name and surname, address, zip code, city name, country of origin, E-mail, the type of facility you stayed in, how you heard about the aquapark, age.

Neither the organizers employees nor the members of their family can participate in the prize game. Family members include: parents, children (stepchildren), spouse, brothers and sisters.

The prizes are not exchangeable for money nor any other value.

Article 7.

All visitors to Aquapark Istralandia have the right to participate in the prize game if they buy tickets from the 3rd of June to the 17th September 2017, and if they fill them out according to the instructions and place them in a drum that is next to the exposed car in the atrium of the Istralandia water park (hereinafter Participants of the prize game). Participants of the prize game, by the act of inserting the tickets to the drum, also confirm that: i) they fully understood and accepted these rules; li) give their express consent to Aquapark Istralandia to collect, process and use their personal data indicated on these bids for the purpose of promoting Aquapark Istralandia's activities.

Participants of the prize game enter the following participant's details on the coupon: name and surname, address, zip code, city name, country of origin, phone number, e-mail, type of facility you have stayed in, how you have heard about the aquapark, age .

All participants of the prize game have the right to participate in the prize game with all coupons, with the exception of younger than 18.

Article 8.

Drawing of the winner of the prize game begins in the presence of a three-member committee, during which a record will be certified by a notary public.

Out of the 4 coupons drawn, they have to be owned by four different people, and the guests themselves choose a closed envelope with prizes. Guests do not have to be present on the day of the draw at the aquapark Istralandia on the 17th of September 2017. The winners will be

informed about the rewards in writing by the Management Board by a certified letter from the public notary.

Article 9.

The deadline for collecting the prize is 30 days from the date of receipt of the written notice of the winnings. If the winners do not receive the prize within that time, the Organizer will act according to the Rules for the Prize game. The prize is taken over by the winners either personally or through a legally validated power of attorney.

The organizer has no other obligations toward the winner than the award of prizes within the time limit specified in the previous paragraph, ie to the participants of the prize game who are not entitled to any prizes at all.

Article 10.

The publication of the results will be visibly reported on the entry of Aquapark Istralandia's administrative building at the cash register as well as in electronic media and on the facebook page: aquapark Istralandia, the next day after winning the winner.

The Organizer undertakes to submit information on prize winners within 8 days of awarding to the Croatian Ministry of Finance and Tax administration

This prize game rules will be published from the date of entry to the end of the prize game on the website www.istralandia.com and physically displayed on the cash registers referred to in paragraph 1 of this Article, and the Organizer may submit their copy to the visitors of Aquapark Istralandia if requested so, at no cost.

Article 11.

The organizer may temporarily suspend or cancel the prize game in the event of force majeure, with the approval of the Ministry of Finance.

Article 12.

In the event of a possible dispute, the Municipal Court in Pula is competent. These Rules are governed by Croatian law.

Article 13.

This prize game rules shall become valid on the 1st of June 2017. and will be valid until the expiration of the award deadline (Article 9).
